#### VILLAGE HALL LOBBY FLOORING

The village hall lobby flooring was replaced during the week of December 18.

#### **BOARD OF ETHICS ADVERTISEMENT**

The advertisement for the vacancies on the newly created Board of Ethics will be published this week, and consideration on appointments to the board will be on Village Council's February 12 meeting agenda.

#### VILLAGE PROPERTY INVENTORY PROJECT STATUS UPDATE

Staff met with McKenna and the Village Engineer on January 2 to review the progress of the village hall property inventory project. Preliminary data on village owned property has been collected and mapped. Changes are needed to the draft. Public Works Director Sanchez will be working with McKenna on site inspections to identify any structures or uses established by others so that an inventory of improvements can be done as part of the final report. Once the inventory and maps are completed, Village Council will need to provide administration with direction on any actions to be taken to resolve private use of the village owned properties.

#### MOBILE FOOD ESTABLISHMENTS ORDINANCE

Consideration of changes to the Mobile Food Establishments Ordinance will be on Council's January 22 meeting agenda for further discussion.

#### **DEPUTY CLERK/TREASURER RECRUITMENT**

We began advertising the Deputy Clerk/Treasurer position opening this week and will be reviewing applications on February 1.

#### PARK AVENUE RETAINING WALL REPLACEMENT PROJECT

We will be working to set up another meeting as soon as possible with affected property owners on Park Avenue to continue discussions on the retaining wall replacement scope of work and cost sharing.

#### REDEVELOPMENT READY COMMUNITIES (RRC) PRESENTATION

Village Council will receive a presentation from the Michigan Economic Development Corporation on the Redevelopment Ready Communities (RRC) program at Council's January 22 meeting. Council requested this presentation prior to authorizing McKenna to begin work on the Master Plan strategic plan.

#### CIVICPLUS MEETING ESSENTIALS AGENDA MANAGEMENT SYSTEM

Administration is continuing its work with CivicPlus to migrate to the Meeting Essentials agenda management system. This system will replace the current Granicus IQM2 MinuteTraq system. I am hoping to have the new system operational for the first Council meeting in April.

#### SPECIAL COUNCIL MEETING

At the request of Village Attorney Kucharek, President Narsh has called a special meeting of Village Council for Monday, November 22, at 6:30 PM, for the purpose of convening into closed session to discuss pending litigation.

#### INDIANWOOD ROAD CULVERT REPLACEMENT PROJECT

Indianwood Road between M-24 and Joslyn Road will be closed for much of the 2024 year for the replacement of the Paint Creek culvert. During road closures, the traffic detour will run from Indianwood Road down Joslyn Road to Clarkston Road to M-24 and vice-versa. Attached is additional information regarding this project.

# INDIANWOOD RD. CULVERT REPLACEMENT WORK TO START IN EARLY JANUARY WITH ROAD CLOSURE

The Road Commission for Oakland County (RCOC), in partnership with Orion Township, will replace the culvert that carries Indianwood Road over the Paint Creek between Fernhurst Dr. and Abseguami Trail in 2024.

### PROJECT DETAILS

The project will include:

- Replacement of the failing metal culvert that currently carries the road over the Paint Creek with a precast concrete culvert.
- Curbs and gutters will be added to the road in the vicinity of the new culvert.
- There will be storm sewer and drainage improvments.
- New asphalt pavement will be placed over the new culvert.
- New guardrail will be installed adjacent to the new culvert.
