1. Police Department Services and Staffing

**RESOLVED:** To authorize the Police Chief to work with the Michigan State Police, the Oakland County Sheriff, and Auburn Hills Police Department to arrange temporary police services up to 90 days, with the Chief to report back to Village Manager on the status.

Chief Stanfield reviewed the police department's current staffing situation. With the recent resignations of officers Loomis and Brown, the Chief is the only full-time office left after December 2, 2023. There are four part time officers, but it is difficult to get the part-time officers to work. The Chief has advertised since August 1 for full time officer positions and only received eight applicants, interviewing three of those applicants in late September. Two of the interviews didn't work out. The Chief has received four recent applications and is starting background investigations. However, even with hiring new officers with little or no experience, it takes at least three months to train. Chief Stanfield presented the following options to address staffing shortages:

- Work out an arrangement with the Village of Oxford to share officers for midnight shifts
- Contract with Oakland County Sheriff
- Seek assistance from the Michigan State Police
- Dissolve the police department

Chief Stanfield stated that he has reached out to Oxford's chief, who indicated that their department, too, is short-staffed and cannot help. Chief Stanfield has not yet reached out to any other agencies, preferring instead to meet with council to discuss the situation first.

Council Member Moshier asked why officers are leaving.

Chief Stanfield stated that pay and benefits are the reason. Even Metamora is now paying \$30.00 per hour for part time officers. The Chief stated that Lake Orion provides no retiree health insurance and no pension.

Village Manager McClary stated that the village does provide a defined contribution retirement program for employees but phased out the defined benefit pension system.

President Narsh inquired as to whether the Chief has called the Michigan State Police. Chief Stanfield stated that he has not yet contacted them.

Council Member Moshier stated that Lake Orion residents want local police.

President Narsh suggested that Chief Stanfield consider doing the following: First, call the Michigan State Police at the Groveland Township Post to see if MSP can provide assistance. There is no cost for their assistance. Second, contact the Oakland County Sheriff to see if the village can contract with them for 90 days for midnight shifts only and two days during the week to cover when the Chief is off.

Council Member Lamb left the meeting at 6:55 PM and returned at 6:56 PM.

Council Member Van Portfliet suggested seeking temporary assistance from other agencies while, concurrently, working on the hiring of full-time officers. He asked if it is possible to talk to other area communities for staffing assistance.

Village Manager McClary stated that any contract for services would require approval from the Village Council, as the council is the only body authorized by charter to contract on behalf of the village.

Chief Stanfield stated that Village Council should consider allowing him to reduce the number of part time police officers and replace with a fifth full time officer to help hiring efforts, reduce overtime costs, and to provide more stability to the department.

**Motion to:** consider creating a fifth full time Police Officer position and reduce part time and overtime hours, with the Chief and Village Manager to bring a definitive cost proposal at the appropriate time.
